He said, "We have received the tracts a few hours ago by God's grace. The pallets are taken to the storage house by 4 local transportation trucks. About 10 brothers stacked them in the house we rented. While the brothers were stacking the boxes, I witnessed to 3 truck drivers. Two of them accepted Jesus Christ as their personal Savior and Lord. That is a good beginning.

Things didn't go smoothly in India. It has been quite an experience to get the container cleared in customs office. We praise God for you and your assistance in spreading the Gospel in this hard soil. Thank you for all your help in all the process until the tracts reach us. God gave us His special grace in all this. We will distribute these precious tracts to many and also distribute to the needy people who would also distribute them."

Because of your faithful prayers and donations, we can share wonderful testimonies like this that serve as reminders that your support is making an eternal difference. As we continue sending the Gospel into places we may never personally go, God is still working. May the Lord bless you for your faithfulness and your desire to see His Word go forth.
